With reference to letter and email to you dated 14/06/2019 and 19/06/2019, respectively notifying you of your apparent Missed Test and inviting you to provide any comments within 14 days of the date of that letter.

Declaration of Missed Test

We have received your response vide email dated 10/07/2019, in which you acknowledge your failure to be available for Testing at the date, time and place specified in your most recent Whereabouts Filing. We have gone through your comments carefully, but we maintain that, in the circumstances, a Missed Test should be recorded against you for the following reasons: as per your reply, you received an urgent call from your Mumbai head office to join camp in Mumbai, as a result of which you missed the dope test conducted by NADA. However, as per notice for inclusion in National Registered Testing Pool (NRTP), whenever there is a change in your whereabouts it becomes the responsibility of athlete to update/notify NADA about change in whereabouts location or time via ADAMS or email (nadaregisteredpool@gmail.com).

I am therefore writing to confirm that we intend to record a Missed Test against you, with the Consequences set out in my letter dated 14/06/2019.

Right to Administrative Review

You have the right to request an administrative review of this decision, in which a *Person* not previously involved in the assessment of this matter would review the file to determine whether or not all elements of a Missed Test specified in the International Standard for Testing and Investigations Article I.4.3 are present.
