**Objections to the names sent by Chandigarh Kabaddi Association (CKA) for
preparation of "Electoral College" for holding Second Round of Election of
AKFI on 01.09.2019**

ORDER

1. Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of "Electoral College".
2. Chandigarh Kabaddi Association Reg. No. 723/1975, an affiliated unit of AKFI has sent names of its two representatives namely Mr. Hem Raj and Mr. Sanjeev Bharanta of the Association. Against these two names, we have received two other names of Mr. Anil Kumar and Mr. Harjit Singh Saini from 'Chandigarh Kabaddi Association' and further two names of Mr. Sunil Kumar and Mr. Ram Mehar from 'Aayush Kabaddi Association of Chandigarh'; another set of two more names

Mr. Kuldeep Singh and Mr. Virender Singh from 'Aayush Kabaddi Association of Chandigarh'.

3. It is relevant to note that similarly at the time of conducting First Round of Election of AKFI on 15.02.2019, Chandigarh Kabaddi Association sent names of Mr. Hemraj and Mr. Sanjeev Bharanta to participate in the elections. Against those two names objections were filed by 10 clubs operating in Kabaddi Game in the Union Territory of Chandigarh. These objections were heard on 22.11.2018. On behalf of the objectors Mr. Harjit Singh Saini, Dr. Sarabjit Singh and Mr. Mukesh had appeared. Those objections were decided by a detailed order dated 17.01.2019. The names sent by CKA were accepted for the limited purpose of preparation of "Electoral College" to hold First Round of Election only to amend the Constitution of AKFI in terms of judgment of Hon'ble Delhi High Court.
4. The objectors have not challenged the order dated 17.01.2019. CKA led by Mr. Hemraj President and Mr. Sanjeev Bharanta General Secretary continues to be the affiliated unit of AKFI. 'Chandigarh Kabaddi Association led by Mr. Anil Kumar and Mr. Harjit Singh Saini has not yet been recognised as the affiliated unit of AKFI. Similarly



'Aayush Kabaddi Association of Chandigarh' has also not been recognised as the affiliated unit of AKFI.

5. As per the Constitution of AKFI and the Model Election Guidelines the "Electoral College" is to consist of permanent Member State / Union Territory duly affiliated by its Federation i.e. AKFI.
6. Since 'Chandigarh Kabaddi Association' HKA led by Mr. Anil Kumar and Mr. Harjit Singh Saini and 'Aayush Kabaddi Association of Chandigarh' AHNSKA are not the affiliated Units / Members of AKFI, names sent by them of Mr. Anil Kumar, Mr. Harjit Singh Saini and Mr. Sunil Kumar and Mr. Ram Mehar and Mr. Kuldeep Singh and Mr. Virender respectively to attend the Annual General Body Meeting of AKFI on 01.09.2019 at New Delhi cannot be accepted. Accordingly, the names sent by 'Chandigarh Kabaddi Association' and 'Aayush Kabaddi Association of Chandigarh' are rejected.
