for preparation of "Electoral College" for holding Second Round of Election

of AKFI on 01.09.2019

## ORDER

- Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of "Electoral College".
- Delhi State Kabaddi Association, an affiliated unit of AKFI has sent names of its two representatives namely Mr. Ch. Zile Singh President and Mr. Niranjan Singh General Secretary of the Association. Against these two names, we have received two other names of Mr. Surendra Kumar and Mr. Surendra Singh from Delhi State Kabaddi Association (Regd.).

- 3. It is relevant to note that similarly at the time of conducting First Round of Election of AKFI on 15.02.2019, Delhi State Kabaddi Association sent names of Mr. Ch. Zile Singh and Mr. Niranjan to participate in the elections. Against those two names objections were filed by Mr. Mahipal, Mr. Surender Kumar, Mr. Virender Kumar and Mr. Ashok. These objections were heard on 26.12.2018. On behalf of the objectors Mr. Mahipal, Mr. Surender Kumar, Mr. Virender Kumar and Mr. Ashok had appeared. Those objections were decided by a detailed order dated 21.01.2019. The names sent by DSKA were accepted for the limited purpose of preparation of "Electoral College" to hold First Round of Election only to amend the Constitution of AKFI in terms of judgment of Hon'ble Delhi High Court.
- 4. The objectors have not challenged the order dated 21.01.2019. DSKA led by Mr. Zile Singh President and Mr. Niranjan Singh General Secretary continues to be the affiliated unit of AKFI. DSKA (Regd.) led by Mr. Surendra Kumar and Mr. Surendra Singh has not yet been recognised as the affiliated unit of AKFI. The election allegedly conducted by them on 17.03.2019 have no impact.

Since DSKA (Regd.) led by Mr. Surender Kumar and Mr. Surendra Singh is not the affiliated Unit / Member of AKFI names sent by it of Mr. Surendra Kumar and Mr. Surendra Singh to attend the Annual General Body Meeting of AKFI on 01.09.2019 at New Delhi cannot be accepted. Accordingly, the names sent by DSKA (Regd.) are rejected.
