**Objections to the names sent by Amateur Kabaddi Association Haryana  
(AKAH) for preparation of "Electoral College" for holding Second Round of  
Election of AKFI on 01.09.2019**

**ORDER**

1. Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of "Electoral College".
2. "Amateur Kabaddi Association Haryana", an affiliated unit of AKFI has sent names of its two representatives namely Mr. Dharmbir Malik and Mr. Kuldeep Singh Dalal of the Association. Against these two names, we have received two other names of Ms. Suman Manjari and Mr. Karambir Singh from "Haryana Kabaddi Association (HKA)" and further two names of Mr. Kuldeep Singh and Mr. Virender Singh have also been received on 17.08.2019 at 8.03 pm by email (Names have been received beyond date and time fixed for receiving names

by the notice dated 07.08.2019) from “Amateur Haryana N.S Kabaddi Association (Regd.) (AHNSKA)”.

3. It is relevant to note that similarly at the time of conducting First Round of Election of AKFI on 15.02.2019, Amateur Kabaddi Association Haryana sent names of Mr. Krishan Lal Panwar and Mr. Kuldeep Singh Dalal to participate in the elections. Against those two names objections were filed by Mr. Vijay Prakash on behalf of ‘HKA’. These objections were heard on 10.12.2018. On behalf of the objectors Mr. Vijay Prakash and Ms. Suman Manjari had appeared. Those objections were decided by a detailed order dated 25.01.2019. The names sent by AKAH were accepted for the limited purpose of preparation of “Electoral College” to hold First Round of Election only to amend the Constitution of AKFI in terms of judgment of Hon’ble Delhi High Court.
4. The objectors have not challenged the order dated 25.01.2019. AKAH led by Mr. Krishan Lal Panwar President and Mr. Kuldeep Dalal General Secretary continues to be the affiliated unit of AKFI. ‘HKA’ led by Ms. Suman Manjari and Mr. Karambir Singh has not yet been



recognised as the affiliated unit of AKFI. Similarly "AHNSKA" is also not been recognised as the affiliated unit of AKFI.

5. As per the Constitution of AKFI and the Model Election Guidelines the "Electoral College" is to consist of permanent Member State / Union Territory duly affiliated by its Federation i.e. AKFI.
6. Since 'HKA' led by Ms. Suman Manjari and Mr. Karambir Singh and "AHNSKA" are not the affiliated Units / Members of AKFI, names sent by them of Ms. Suman Manjari, Mr. Karambir Singh and Mr. Kuldeep Singh and Mr. Virender Singh respectively to attend the Annual General Body Meeting of AKFI on 01.09.2019 at New Delhi cannot be accepted. Accordingly, the names sent by 'HKA' and "AHNSKA" are rejected.
