**Objections to the names sent by Kabaddi Association of Jharkhand (KAOJ)  
for preparation of "Electoral College" for holding Second Round of Election  
of AKFI on 01.09.2019**

**ORDER**

1. Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of "Electoral College".
2. Kabaddi Association of Jharkhand (KAOJ), an affiliated unit of AKFI has sent names of its two representatives namely Mr. Rajeev Ranjan Mishra President and Mr. Bipin Kumar Singh General Secretary of the Association. Against these two names, we have received two other names of Mr. Sushil Kumar and Mr. Sanjay Kumar Jha from 'Jharkhand State Kabaddi Association (JSKA)' and further two names of Mr. Laxman Kumar Rajak and Mr. Shiv Sagar from 'Kabaddi Association Of Jharkhand'.

It is relevant to note that similarly at the time of conducting First Round of Election of AKFI on 15.02.2019, Kabaddi Association of Jharkhand had sent names of Mr. Rajeev Ranjan Mishra and Mr. Bipin Kumar Singh to participate in the elections. Against those two names objections were filed by Mr. Sanjay Kumar Jha on behalf of 'JSKA'. These objections were heard on 05.12.2018. On behalf of the objectors Mr. Sanjay Kumar Jha and Mr. Harish Kumar had appeared. Those objections were decided by a detailed order dated 25.01.2019. The names sent by KAOJ were accepted for the limited purpose of preparation of "Electoral College" to hold First Round of Election only to amend the Constitution of AKFI in terms of judgment of Hon'ble Delhi High Court.
4. The objectors have not challenged the order dated 25.01.2019. KAOJ led by Mr. Rajeev Ranjan Mishra President and Mr. Bipin Kumar Singh General Secretary continues to be the affiliated unit of AKFI. 'JSKA' led by Mr. Sushil Kumar and Sanjay Kumar Jha has not yet been recognised as the affiliated unit of AKFI. Similarly 'Kabaddi Association of Jharkhand' led by Laxman Kumar Rajak and Mr. Shiv Sagar was also not been recognised as the affiliated unit of AKFI.



5. As per the Constitution of AKFI and the Model Election Guidelines the “Electoral College” is to consist of permanent Member State / Union Territory duly affiliated by its Federation i.e. AKFI.
6. Since ‘JSKA’ led by Mr. Sushil Kumar and Mr. Sanjay Kumar Jha and ‘Kabaddi Association Jharkhand’ led by Mr. Laxman Kumar Rajak and Mr. Shiv Sagar are not the affiliated Units / Members of AKFI, names sent by them of Mr. Sushil Kumar and Mr. Sanjay Kumar Jha and Mr. Laxman Kumar Rajak and Mr. Shiv Sagar respectively to attend the Annual General Body Meeting of AKFI on 01.09.2019 at New Delhi cannot be accepted. Accordingly, the names sent by ‘JSKA’ and claimed ‘Kabaddi Association of Jharkhand’ are rejected.
