**Objections to the names sent by Telangana Kabaddi Association (TKA) for
preparation of "Electoral College" for holding Second Round of Election of
AKFI on 01.09.2019**

ORDER

1. Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of "Electoral College".
2. Telangana Kabaddi Association (TKA), an affiliated unit of AKFI has sent names of its two representatives namely Mr. Kasani Gnaneshwer Mudiraj, President and Mr. K. Jagadishwer Yadav Secretary of the Association. Besides this, two more names have also been received of Mr. A. Ushi Reddy and Mr. G. Srikanth who also claim themselves to be the President and Secretary of Telangana Kabaddi Association elected on 16.02.2019 in an election conducted

3. Representations dated 23.02.2019 and 30.03.2019 were made by Mr. A. Ushi Reddy requesting for issuance of affiliation / recognition to Telangana Kabaddi Association represented by him as its General Secretary and Mr. Godila Srikanth Goud as its President. The said representations have been disposed of by an order dated 01.07.2019 with an observation that Telangana Kabaddi Association being represented by Mr. Kasani Gnaneshwer Mudiraj and Mr. K. Jagadishwer Yadav continues to be the affiliated and recognised unit of AKFI.

By an order dated 18.01.2019 whereby objections received against names of two authorised representatives for the formation of "Electoral College" for holding the First Round of Election were decided by a comprehensive order. All the State Associations including Telangana Kabaddi Association were directed to amend their Constitution to make it in compliance with Sports Code and then to hold election of its Office Bearers in compliance with Model Election Guidelines preferably within one month. were made for the affiliated units of AKFI. Telangana Kabaddi Association being represented by Mr. G. Srikanth as President or Mr. A. Ushi Reddy as Honorary Secretary was not the affiliated unit of AKFI. "Telangana Kabaddi Association" being represented by Mr. A. Ushi Reddy was never authorised by the said order dated 18.01.2019 to amend the Constitution of Telangana Kabaddi Association and to hold elections of its Office Bearers. In these terms representations filed by Mr. A. Ushi Reddy were found without merits and were dismissed.

It was further observed that there could not be two Associations, one led by Mr. Mudiraj as its President and the other led by Mr. G. Srikanth. Election of Office Bearers of "Telangana Kabaddi Association" declared on 16.02.2019 could not be given effect to grant recognition and affiliation to "Telangana Kabaddi Association" represented by Mr. G. Srikanth as its President.

4. It is relevant to observe that at the time of conducting First Round of Election of AKFI on 15.02.2019, Telangana Kabaddi Association had sent names of Mr. Kasani Gnaneshwer Mudiraj and Mr. K. Jagadishwer Yadav to participate in the elections. Objections

received against those two names were decided after giving hearing to both sides by a comprehensive order dated 18.01.2019. The order was put on the website of AKFI and was conveyed to objectors by email. In the said order it was specifically observed that for the purpose of conducting First Round of Election to elect the Office Bearers to amend the MOA of AKFI, names sent by Telangana Kabaddi Association of Mr. Kasani Gnaneshwer Yadav and Mr. K. Jagadishwer Yadav were to be accepted. "Telangana Kabaddi Association (TKA)" represented by these two Office Bearers namely Mr. Kasani Gnaneshwer Yadav and Mr. K. Jagadishwer Yadav continues to be the affiliated unit of AKFI. "The Telangana Kabaddi Association" being led by Mr. G. Srikanth as its President has not been given any affiliation by AKFI so far. Election allegedly conducted on 16.02.2019 has no impact.

5. As per the Constitution of AKFI and the Model Election Guidelines the "Electoral College" is to consist of permanent Member State / Union Territory duly affiliated by its Federation i.e. AKFI.



6. Since "Telangana Kabaddi Association" led by Mr. G. Srikanth and Mr. A. Ushi Reddy is not the affiliated Unit / Member of AKFI, names sent by it of Mr. G. Srikanth and Mr. A. Ushi Reddy to attend the Annual General Body Meeting of AKFI on 01.09.2019 at New Delhi cannot be accepted. Accordingly, the names of Mr. G. Srikanth and Mr. A. Ushi Reddy are rejected. Names sent by Telangana Kabaddi Association of Mr. Kasani Gnaneshwer Mudiraj and Mr. K. Jagadishwer Yadav shall be included in the "Electoral College".
