**Objections to the names sent by Amateur Kabaddi Federation of India
West Bengal State Unit (AKFIWBSU) for preparation of "Electoral College"
for holding Second Round of Election of AKFI on 01.09.2019**

ORDER

1. Pursuant to the notice dated 07.08.2019 to convene AGM of AKFI primarily for holding of Second Round of Election of the Office Bearers of AKFI in terms of the judgment dated 03.08.2018 of the Hon'ble Delhi High Court in Writ Petition No. 4601/2013 and order dated 05.07.2019 of Hon'ble High Court of Delhi, names have been called for preparation of "Electoral College".
2. Amateur Kabaddi Federation of India West Bengal State Unit (AKFIWBSU), an affiliated unit of AKFI has sent names of its two representatives namely Mr. Subrata Mukherjee President and Mr. Radheshyam Agarwal General Secretary of the Association. Against these two names, we have received two other names of Mr. Prabhat Paul and Mr. Shyamal Kumar Basu from "Bengal Amateur Kabaddi Association (BAKA)" and further two names of Mr. Biswanath Chakraborty Chairman and Mr. Hiran Kanti Sinha Joint Secretary from "West Bengal Kabaddi Association (WBKA)".

It is relevant to note that similarly at the time of conducting First Round of Election of AKFI on 15.02.2019, Amateur Kabaddi Federation of India West Bengal State Unit sent names of Mr. Subarata Mukherjee and Mr. Swapan Mahapatra to participate in the elections. Against those two names objections were filed by Mr. Shyamal Kumar Basu on behalf of 'BAKA' and Mr. Sajal Ghosh on behalf of 'WBKA'. These objections were heard on 08.12.2018. On behalf of the objectors Mr. Biswanath Chakraborty, Mr. Biswajit Palit, Ms. Rama Sarkar, Mr. Habib Ali, Mr. Shyamal Kumar Basu, Mr. Manoj Kumar Dey, Mr. Sajal Ghosh, Mr. Dilip Palit, Mr. Nemai Ch. Biswas, Mr. K. Patra, Mr. Biswanath Ahish and Mr. Swapan Kumar Pal had appeared. Those objections were decided by a detailed order dated 23.01.2019. The names sent by AKFIWBSU were accepted for the limited purpose of preparation of "Electoral College" to hold First Round of Election only to amend the Constitution of AKFI in terms of judgment of Hon'ble Delhi High Court.
4. The objectors have not challenged the order dated 23.01.2019. AKFIWBSU led by Mr. Subarata Mukherjee President and Mr. Radheshyam Agarwal General Secretary continues to be the affiliated unit of AKFI. 'BAKA' led by Mr. Prabhat Paul and Shyamal Kumar Basu



has not yet been recognised as the affiliated unit of AKFI. Similarly 'WBKA' led by Ajgar Ali and Biswanath Ghosh has also not been recognised as the affiliated unit of AKFI.

5. As per the Constitution of AKFI and the Model Election Guidelines the "Electoral College" is to consist of permanent Member State / Union Territory duly affiliated by its Federation i.e. AKFI.
6. Since 'BAKA' led by Mr. Prabhat Paul and Shyamal Kumar Basu and 'WBKA' led by Ajgar Ali and Biswanath Ghosh are not the affiliated Units / Members of AKFI, names sent by them of Mr. Prabhat Paul and Mr. Shyamal Kumar Basu and Mr. Biswanath Chakraborty and Mr. Hiran Kanti Sinha respectively to attend the Annual General Body Meeting of AKFI on 01.09.2019 at New Delhi cannot be accepted. Accordingly, the names sent by 'BAKA' and 'WBKA' are rejected.
